SR Division met with of the Commercial Staff on 17 July 1958 in the CM Library to discuss the latest developments in the AEDINOSAUR case. 2. pointed out that had contacted SR Division and had informed them that the planning to publish the book in question. was interested inknowing the extent of SR's interest in getting copies. SR requested to determine where the obtained the plates, whether they had the rights, and the cost per copy of the edition they plan to is to advise SR of this information on Friday, 18 July. publish, 3. announced that he had picked up a package during his latest visit to New York which it was assumed contained the plates for the book. As regards the recent rumors as to European publishing of the book. advised that Feltrinelli, the Italian publisher, had no facilities for publishing the book in Russian, but that he had to try and make arrangements for publishing in the Russian language.
